The Hon'ble Vice Chancellor expressed his displeasure at the members and the Chairman of the Doctoral Programme Committee of the Department of Geography for their laidback approach being the laggard in finalizing the Ph. D. admissions for year 2018-19. The Department was directed to finish the work as early as possible, but not later than in a week's time. The Chairman and the members of the DPC (Geography Dept.) assured the Chairman to comply with the directions of the Academic Council and

they would not give any occasion in future where they could be caught on the wrong side of the affairs.

On a query by the Director of Admissions, Prof. Man Mohan Krishna regarding two separate MCA Courses with the same Syllabus being offered by two different units, JK Institute and the IPS, of the same University, it was clarified that the MCA Course offered by the JK Institute was a regular course and the MCA Course offered by IPS was a self finance course.

As all the Agenda Items were discussed, Dr. Anand Shankar Singh, Principal, ISDC, informed the Academic Council that the Rationalization Committee (consisting of Professors Jagdamba Singh, Man Mohan Krishna, Anand Shankar Singh as Members, Sri Devesh Kumar Goswami, Asstt. Registrar, Convener and S. A. Ansari, Chairman) for Constituent Colleges constituted by the Hon'ble Vice Chancellor had finished the task and submitted the report to the Registrar for necessary approval of the Finance Committee before its implementation. The Hon'ble Vice Chancellor lauded the Committee for its valuable contribution and led the Academic Council to give big hand to the Committee. Besides this, the commendable work done for the University by Professors S.I. Rizvi, Man Mohan Krishna, J.A. Ansari, R.K. Singh, Anupam Dikshit, A.R. Siddiqui, Sunit Dwivedi and Neelam Yadav in different capacities were highly appreciated and acknowledged.

The meeting came to an end with a vote of thanks to the Chairman.
