The Chairman extended a warm welcome to all members of Academic Council, Special Invitees and the newly appointed Heads of Department. Thereafter, the agenda items were taken up.

Agenda No.01/38

To consider the conferment of the Degree of Doctor of Letters (D.Litt.) Honoris Causa to the person(s) of excellence in Academic, Social and Cultural fields at the Convocation scheduled to be held on 5th September, 2019.

Resolution No.01/38 The recommendation dated 19th August, 2019 of the Board of Studies, Department of Political Science, University of Allahabad (duly forwarded by the Dean, Faculty of Arts) requesting the University to award the Degree of Doctor of Letters (D.Litt.) Honoris Causa to the eminent alumnus and a very distinguished I.P.S. Officer, Shri O.P. Singh was placed for the consideration of the Academic Council.

> After due consideration the Academic Council unanimously resolved to approve the recommendation of the Board of Studies, Department of Political Science, University of Allahabad (duly forwarded by the Dean, Faculty of Arts) to award the Degree of Doctor of Letters (D.Litt.) Honoris Causa to Shri O.P. Singh. It was further resolved to recommend the same to the Executive Council for its approval. The recommendation dated 19th August, 2019 is appended here as Appendix-A.

#### Any Other Matter With the Permission of the Chair

The Chairman permitted to consider the following three separate but urgent matters and they were added as Agenda Nos. 02/38, 03/38 and 04/38:

Agenda No. 02/38

To consider the establishment of the Centre for Child Rights in the University of Allahabad.

Resolution No.02/38 The Chairman informed the members that the University should start a Centre for Child Rights. The Academic Council concurred with the views expressed by the Chairman and decided to constitute the following Committee under the Chairmanship of Prof. P. K. Sahoo, Dean, Faculty of Arts to work out its complete modalities within two weeks:

It was further resolved to authorize the Vice Chancellor to approve the report of the Committee and the same would be reported to the Academic Council in its next meeting.

#### Agenda No. 03/38

To consider the Ph. D. Admission related matters arising out of the CRET 2019.

#### Resolution No.03/38

The members were informed that in some of the subjects the number of candidates who had qualified the CRET - 2019 was very inadequate. Taking an over-all view of the problem, the Academic Council unanimously resolved to (a) allow all such CRET -2019 applicants who had been declared as JRF by the UGC to be interviewed by the respective Doctoral Programme Committee, irrespective of their place in the CRET-2019 result declared by the Director (Admissions) in July/August, 2019, along with other candidates who had been declared as qualified in the said result, for Ph. D. Admission in all Departments/Centres/Institutes/Constituent Colleges; and (b) hold a fresh CRET- 2019 for only such subjects in which the number of candidates declared as qualified for Interview for admission was found to be too inadequate and for this purpose the following new CRET-2019 Admission Committee was constituted:

(1) Prof. Neelam Yadav, Director, IPS, U.A. Chairperson (2) Prof. I.R. Siddiqui, Department of Chemistry, U.A. Member (3) Prof. Anupam Pandey, Department of Geography, U.A. Member

The Committee was also authorized to co-opt younger colleagues to expedite the completion of the whole process of fresh admission within a period of four weeks. The Reservation Policy as announced by the UGC would be implemented in letter and spirit.

It was further resolved that from such JRF students who were residing in the University/University Recognized Hostels the House Rent allowances drawn by them would be recovered and the same would be deposited in the University, if the candidates were residing in the University Hostel or with the Management Committee if the candidates were residing in the University Recognized Hostel. The Dean, Students' Welfare was requested to expedite

the recovery and deposit of such amounts in the University or the respective hostel.

At this stage Prof. D.C. Lal informed the Academic Council that there were a number of research scholars who had been remaining absent from their respective departments without any proper leave having been granted to them. The Academic Council took a very serious view of the situation and resolved to constitute a Committee under the Chairmanship of Prof. D.C.Lal, who would submit a report to the Chairman after visiting each department.

Agenda No. 04/38

To consider the letter dated 27th July, 2019 of Col. P. S. Tivetia, Addl. Chief Engineer, MES (Air Force), Allahabad forwarding the application dated 24<sup>th</sup> July, 2019 of Col. P. K. Dhaka, who had been recently posted at Allahabad on transfer from Jodhpur, for admission of his son, Divyam Dhaka in the Second Year of B.Sc. (PCM) Course of the University of Allahabad as the candidate had already passed the First Year of B.Sc. (PCM) Course from JNV University, Jodhpur.

Resolution No.04/38 The Academic Council considered the application very sympathetically as it was a genuine request from a person who was serving in the armed forces and the problem his son was facing was only due to the transfer of his father from Jodhpur to Allahabad (now Prayagraj). In that background the members unanimously resolved to grant the request on production of the Migration Certificate by the candidate from J.N. Vyas University, Jodhpur, as it was also permissible under the UGC letter vide No. D.O. No. F.1-1/2014(Secy) dated 12<sup>th</sup> November, 2014. It was further resolved that such transfer facility would be granted by the Vice Chancellor, on case to case basis, to the wards of armed forces only. The documents mentioned in the Agenda item and the resolution are appended here as Appendix-B.

The meeting ended with a vote of thanks to the Chair.
