- (v) The remuneration for the Guest Faculty shall be as per UGC norms.

- (xiii) Candidates belonging to SC/ST/SEBC category should submit proper caste certificate as per the proforma of Govt. of India.
- (xiv) Candidates belonging to SEBC category, but coming in creamy layer will not be entitled to the benefits of reservation and should apply as General Category candidate.
- (xv) Candidates belonging to EWS category should submit proper certificate as per the proforma of Govt. of India.
