The Chairman extended a warm welcome to the Hon'ble members.

The Vice-Chancellor brought to the notice of the Hon'ble members the problems faced by the University Administration. He informed that the Admission Tests and annual examinations of the University have been completed in time.

Prof. C.L. Khetrapal, Hon'ble member appreciated the efforts of the University in conducting the admission tests and holding the annual examinations in a time bound manner but at the same time he suggested that the decisions which are taken in the meetings of the Executive Council be implemented timely. Other members of the Executive Council agreed with the views of Prof. Khetrapal.

After ascertaining the completion of quorum, the Chairman called the meeting to order. Subsequently the agenda item were taken up.

As the meeting commenced, certain issues relating to re-employment of teachers were discussed. **It was resolved that** the proposal for re-employment of superannuating teachers be invited from Departments/Centres by the month of April every year.

It was further resolved that if the names of experts for re-employment are not sent by the Departments within the stipulated time, the Vice-Chancellor is authorized to appoint experts in consultation with the Dean of the faculty concerned.

It was also resolved that in case of difference of opinion among members of Expert Committee on re-employment of a teacher, the recommendation and opinions of members should be put before the Executive Council for decision.

Resolution No.02/32 Resolved that the Action Taken Report in pursuance of the decisions taken in the meeting of the Executive Council dated 20-09-2014, 27-01-2015 (adjourned), 02-11-2014 and 01-03-2015 (emergent) be recorded subject to the following:-

While considering the Action Taken Report dated 27-01-2015 vide Resolution No.34/30 the Hon'ble member, Prof. C.L. Khetrapal desired to know the action taken in the case of Dr. Manik Chandra Gupta, Pottery Assistant, Department of Ancient History, Culture & Archeology, University of Allahabad. The Registrar stated that the names of the experts have been received from the Department of Ancient History; presently matter is in process. One Hon'ble member raised the matter of engagement of a Guest Faculty in the Department of Philosophy in the year 2000 who is continuing as such on account of order of the Hon'ble High Court along with the guest faculties engaged in other academic units of the University. The Registrar read out the representation received from the Guest Faculties of the Departments of Philosophy, Geography and Photography under the Department of Physics regarding their claim for regularization on the basis of regularization of twelve academic staff of the University in the year 2009. After thorough discussion it was resolved that a three member Committee be constituted to examine various representations received from the Guest Faculties of various academic units of the University regarding their claim for regularization as under :-

- (1) Prof. V.C. Pande, Retd. Professor, Deptt. of Medieval/Modern History, A.U.
- (2) one member nominated by the Vice-Chancellor, BHU, Varanasi.
- (3) one member nominated by the Vice-Chancellor, Aligarh Muslim University, Aligarh.

Registrar or his nominee will present their cases before the Committee.

The Committee will examine the claims made in the representations in the light of the provisions of the Act, Statute and Ordinances of the University in this regard.

It was further resolved that the recommendations of the Committee will be placed before the Executive Council.

To consider the recommendation of the Academic Council regarding the panel of experts for Selection Committees for regular appointment and promotion of teachers under Career Advancement Scheme (CAS) in various Departments of the University as per the Academic Council Resolution No. 04/22 dated 12-05-2015.

Resolution No.04/32 All envelopes containing names of the experts for CAS and regular selections were put on the table of the meeting and it was resolved to constitute a broad based Committee consisting of all the Professors of the Departments, one Professor of a Cognate Department nominated by the Vice-Chancellor and Dean of the concerned faculty. The Committee shall be chaired by the Dean of the concerned faculty. In case there is no Professor in any Department, the Vice-Chancellor shall, in consultation with Dean of the concerned faculty, nominate subject experts from outside the University to provide names of the experts. Any person having any interest in the appointment/promotions shall refrain from being a member of the aforesaid Committee. The Committee will submit its recommendations comprising Twenty five (25) names covering all the areas of discipline/subjects, within Ten (10) days. The Vice-Chancellor will be authorized to approve the same on behalf of the Academic Council. This resolution should be implemented immediately to avoid any delay.

Resolution No.05/32 The order dated 19.03.2015 of the Hon'ble High Court in the Writ Petition No. 4178. of 2015 (Dr. Suchitra Mitra and another Vs. Union of India and others) was discussed and it was resolved that the meetings of the Selection Committees for promotion under Career Advancement scheme (CAS) be convened at the earliest after following due process for the appointment of experts for the selection committees.

> The order dated 27.05.2015 of the Hon'ble High Court in Writ Petition No.32264 of 2015 (Prof. S.D. Dwivedi Vs. Union of India and others) was read over by the Registrar. In the course of discussion on this point, the members pointed out that law has always been an important discipline in higher education and the contributions of Hon'ble Judges of the High Court and the Supreme Court cannot be overlooked. After retirement, the Hon'ble Judges of the High Court and Supreme Court are offered Professorships of eminence by various National Law Universities in the country and they are members of various academic bodies in several universities including the University of

Allahabad. It was further pointed out that as per Section 12(b) of U.P. State Universities Act, one member in the Search Committees for the Vice-Chancellors in the U.P. State Universities is invariably a High Court Judge as a nominee of the Chief Justice of the Allahabad High Court. In the University of Allahabad, the Law Faculty has a long tradition of having judges of eminence on its faculty and as members of its academic bodies. The University feels proud in having the Hon'ble Judges of the Supreme Court and High Court on the Panel of Examiners for evaluation of the thesis for D.Phil. Degree in Law. Hon'ble Mr. Justice M.H. Beg, former Chief Justice of India has served on the faculty in the Law Department of the University of Allahabad. Recognizing the academic eminence of Hon'ble Mr. Justice Yatindra Singh, the former Chief Justice of Chhatisgarh High Court, the Faculty of Law, University of Allahabad offered him a Professorship in the Department of Law and he was kind enough to grace the position.

The Executive Council was of the unanimous view that all the aforesaid facts were considered while nominating members for the Search Committee for the Vice-Chancellor and it reiterated and maintained its earlier view and resolved that Hon'ble Mr. Justice Ravi S. Dhawan, former Chief Justice of Patna High Court, who has been nominated by the Executive Council as a member for the Search Committee for the Vice-Chancellor of the University of Allahabad, is undoubtedly a person of academic eminence in the sphere of Higher education.
