At the outset the Vice-Chancellor extended a very warm welcome to the members of the Executive Council and after ensuring the completion of quorum, the Chairman called the meeting to order. The agenda item was taken up. The Chairman informed the members that in the Meeting of the Finance Committee held on Tuesday, 27th June, 2017 at 11:00 A.M. in New Delhi the Annual Accounts of the University for the year 2016-17 were considered and approved for their placement before the Executive Council for its consideration and approval for sending the same to the Principal Director of Audit (Central), Lucknow, Branch Office, Allahabad for conducting audit. The Finance Officer as Secretary of the Finance Committee had been made a Special Invitee at the Executive Council Meeting and he would be presenting the Annual Accounts of the University for the year 2016-17.

The Chairman further informed that in terms of the provisions of sub-Clause (2) of Clause 1 of the Statutes although the five year tenure of the Hon'ble Chancellor,

Professor Goverdhan Mehta, a very eminent Scientist, has expired on 10-06-2017 and the same dignitary would not be eligible for reappointment yet he would continue to hold office until his successor enters upon his office. And as per the provisions of sub-Clause (1) of Clause 1 of the Statutes "The Chancellor shall be appointed by the Visitor from a panel of not less than three persons recommended by the Executive Council from amongst persons of eminence in the academic or public life of the country." Thus the Chairman urged the members to consider this matter also. The Hon'ble members requested the Chairman to take up the matter as "Any Other Matter with the Permission of Chair".
