The Vice-Chancellor/Chairman welcomed the members and apprised them of the reasons for calling the emergent meeting of the Academic Council and directed the Registrar to take up the agenda of the meeting.

Dr. D.C. Lal, HoD, Physical Education circulated a letter questioning the convening of the meeting of the Academic Council and also alleging that the intentions in calling this emergent meeting were not fair (Annexure - I).

Letter dated June 04, 2015 written by Prof. R.C. Tripathi, Member, Executive Council containing suggestions regarding fresh set of names of experts was read out by the Registrar (Annexure - II).

The Registrar informed the Council that two letters have been received in connection with the agenda, one from Prof. Ranjana Bajpai, Department of Ancient History, Culture & Archaeology and another from Prof. U.C. Chattopadhyaya, HoD, Ancient History, Culture & Archaeology (Annexure - III & IV).

The Vice-Chancellor instructed the Registrar to read before the Council the aforesaid four letters. First, the letter of Dr. D.C. Lal, HoD, Physical Education was read over and the Council unanimously $\underline{\textit{decided}}$ that the University administration has no vested interest in convening the meeting, as alleged in the letter of Dr. D.C. Lal. It was also decided that the convening of the A.C. meeting is in the interest of the teachers and that the meetings of the Selection Committees should be convened in compliance of the order of the Hon'ble High Court as well as in accordance with the instructions of the Executive Council held on 02.06.2015.

Thereafter, the agenda was taken up and the envelopes received from the Deans of the Faculties of Arts, Commerce, Law and Science were placed on the table. The Deans of the Faculties affirmed that experts have been appointed from all departments/centers.

Agenda No. 01/24

To consider the names of experts for Selection Committees for promotion under Career Advancement Scheme (CAS) and regular appointment of teachers.

Resolution No.01/24

It was unanimously $\underline{\textit{resolved}}$ that since the envelopes contained the names of the experts as per the instructions of the Executive Council, these envelopes should not be opened in this meeting. However, if any Member of this Academic Council desires to peruse the names of the experts, he/she may do so in the office of the Vice-Chancellor today, i.e. on 13.06.2015. It was also <u>resolved</u> that the list of experts of all the Departments/Centers placed on the table be approved. The Council requested the concerned Deans and the Vice-Chancellor to put their signature on the list of experts of each Department/Centre.



Thereafter two letters of Prof. Ranjana Bajpai, Department of Ancient History, Culture & Archaeology and Prof. U.C. Chattopadhyaya, HoD, Ancient History, Culture & Archaeology were read over by the Registrar in relation to the names of the experts of the Department of Ancient History, Culture & Archaeology.

It was unanimously <u>resolved</u> that since Prof. Ranjana Bajpai failed to participate in the meeting convened by the Dean, Faculty of Arts, the names finalized by the Collegium should be treated as final.
