Resolution No.05/63 The Hon'ble Vice-Chancellor briefly explained the matter to the Council members that only one-man committee was constituted by the Executive Council vide Resolution No.08/56 dated 29-06-2019 to examine this case. The Hon'ble Vice-Chancellor also apprised that in any case of sexual harassment, one woman must be the member of the Committee. Prof. Shailendra Singh Gaurav pointed out that this Committee was constituted only as one member Committee to examine the case and was not an Enquiry Committee. Moreover, Prof. G.C. Tripathi has superannuated from the University services. Thus, this matter may be dropped. Prof. Rohini Prasad and Prof. Somesh Kumar Shukla also asked the Chairperson whether the Council can set up an enquiry against a retired Professor or not?. Further, Prof. Kameshwar Nath Singh, Executive Council Member (Rector Nominee) vide his email dated 24.08.2021 suggested that Prof. G.C. Tripathi has superannuated and therefore the matter may be dropped.

> After thorough deliberation, it was unanimously resolved that this case be referred to the University's Committee for Complaint against Sexual Harassment (C-CASH) which is a mandatory committee in all universities and is constituted for the protection of the women against sexual harassment as per the Hon'ble Supreme Court, Vishkha Guidelines. It was also resolved that the C-CASH will examine the case and give its report which shall be put up in the next Executive Council meeting.

Moreover, a longtime has elapsed and eligibility criteria as well as EWS Reservation Act has been passed. The Registrar requested the members to readvertise these posts and be filled. It was unanimously resolved that the post of Hindi Typist and Hindi Officer will be advertised shortly to fill up the vacant posts.

The Hon'ble Vice-Chancellor apprised the Executive Council members that the Convocation Ceremony will be celebrated every year. Further, the members were apprised about the progress and development regarding preparation for

Convocation. For the Convocation, various committees are set up with specific allotted work. The consent for participation in the Convocation has been received from Mrs. Anandi Ben Patel, the Hon'ble Chief Rector/Governor, Uttar Pradesh, Lucknow, Shri Ashish Kumar Chauhan, as Hon'ble Chancellor, University of Allahabad and Prof. D. P. Singh, Chairman, University Grants Commission, New Delhi. Hon'ble Chairperson Executive Council apprised the members that Padam Bhushan Shri Gulzar has given his consent to accept the Degree of Doctor of Letters (D.Litt.) Honoris Causa on the occasion of Convocation. A letter to the Hon'ble President of India on this award of degree, shall be sent seeking his permission.

Hon'ble Chairperson also apprised that an invitation letter to our alumni Shri Piyush Kumar Dubey, Coach, Indian Men's Hockey Team (Olympic Bronze Medalist) has been sent to felicitate him on Convocation Ceremony.

It was also apprised to the Executive Council members that some new initiatives have been added like Dronacharva Award for the best teacher in the category of Assistant Professor and best Researcher Award. The Dronacharya Award and the best Researcher Award will be given in Faculty of Arts and Faculty of Science. The Faculty of Law will be clubbed with Faculty of Science and Faculty of Commerce with Faculty of Arts.

The University is going to celebrate the Convocation ceremony on its foundation day and conferment of degree along with Medals will be distributed for two consecutive academic sessions i.e. 2018-19 and 2019-20. The large number of eminent personalities and alumni are expected to attend the Convocation ceremony, subject to adherence of Covid Guidelines.

The Executive Council unanimously considered and approved the same.

As per the report, the committee concluded that, Dr. Rohit Kumar Mishra is not fulfilling the requisite qualifications laid down in UGC Regulation for the appointment of the post of Associate Professor. On the basis of the report, it was unanimously resolved that the services of Dr. Rohit Kumar Mishra, Associate Professor, Center for Science & Society (Rural Technology & Development) be terminated with immediate effect. The Registrar/Secretary of Executive Council is directed to take necessary action in accordance with the University Act, Statutes & Ordinances.

Resolution No.22/63 The Hon'ble Vice-Chancellor was apprised of issues pertaining to the absence of teaching and non-teaching staff of the University of Allahabad by Dean, Faculty of Science which hampers not only the routine academic/administrative activity of the University as well as sets up a wrong message towards the working culture of the University. It has been informed to the Chair that one faculty member and few non-teaching staffs are not attending their respective classes/ offices.

(i) The Dean, Faculty of Science through a letter informed to the Chair that Dr. Richa Mishra, Assistant Professor, Department of Electronics & Communication, University of Allahabad is not attending the office even after commencement of academic session 2021-22 w.e.f. 5<sup>th</sup> July, 2021. It is also informed that she is out of country (Australia) without prior approval of the leave sanctioning authority. The Executive Council unanimously criticized her absence from duty and her willful misconduct and disregard to the office of the Vice-Chancellor which in turn raises questions about her commitment towards her duty. **The Executive Council unanimously resolved that** Dr. Richa Mishra be placed under suspension with immediate effect till an enquiry committee submits its report. During the period of suspension, she will be paid subsistence

allowance as per financial rules on her reporting to Office of the Dean, Faculty of Science, University of Allahabad.

(ii) The Dean, Faculty of Science through a letter informed to the Chair that some Class-III employees of the Department of Chemistry, University of Allahabad are absent from their duty since August 2016, but they are getting payment of salary regularly. The Executive Council unanimously criticized this act of willful misconduct. After thorough discussion, the Executive Council authorized the Chairperson of Executive Council to constitute a committee to look into the matter.
