One of the members took serious note of his language. The email wrote "some amendments are needed as the present language seems to show prejudice, vendetta and revengefulness of the Executive Council which was certainly not the intention." This was in context of Agenda No. 8/87 on the matter of Dr. Vivek Kumar Dwivedi, Associate Professor, Department of English.

This was in context of Executive Council meeting dated 07.03.2025 wherein a report of a committee was submitted. Prof. S.K. Sharma came late by 1 $^{1}/_{2}$ hours. The meeting began at 11 A.M. and he entered around 12.30 P.M. when all the members had completed their discussion up till agenda No. 10/11. He was questioned by the Vice-Chancellor about his delayed entry, he made a lame reply, saying he had an upset stomach which was unfathomable, and could not convince the members. Seemingly he has a very callous approach to such a serious meeting which has many crucial issues to delve upon. Such a delay cannot be treated as normal.

When the next meeting took place on 30th April 2025, he had woken up from his slumber and came up with such dastardly language for the entire Executive Council.

He was asked by one member to immediately retract and apologize. He had no choice but to apologize and retract the email. The apex body noted that Prof. S.K. Sharma when he got in the scuffle with Dr. K. Parag, has brought a lot of ill-repute to the University.

To consider the report of the Committee constituted vide notification no. 05/R/383/2025 dated 27.03.2025 to enquire into the incident which took place in the Department of English and MEL on 25.03.2025, between the Head of the Department of English and a faculty member.

Resolution No.09/88 Prof. S.K. Sharma left the meeting due to being party in the aforementioned incident. After going through the report and thorough deliberation reading of report which engaged the Executive Council in discussion, it could not be made clear as to who was the first one to assault, because no third person was available in the HOD room at that time. All the allegations made by Prof. S.K. Sharma on the new incumbent fell flat, after the committee interrogated other concerned faculty members.

> A high powered committee was constituted by the Vice-Chancellor on 27th March 2025. Prof. S.K. Sharma reclused himself when he was called by the committee on the 2nd of April 2025 for the first time. He was again called. He appeared on the 8th of April 2025. Dr. Kumar Parag gave his statement on 2nd April 2025.

> Prof. S. K. Sharma put forth 5 allegations against DR. Kumar Parag. 1. Delay in internal exam marks. 2. Semester time table. 3. Charges in class timings. 4. Certificate from Uttarakhand Public Service Commission to justify duty leave. 5. Not signing of attendance register. Upon interrogation with other faculty members of the Department of English, all them were found to be false. (The committee report is available in the committee section)

> As per the report, the committee went through the attendance register of English Department. It was glaring that Prof. Sharma had never signed his attendance on the register. Upon being asked, by the committee he replied, "I do not agree with the orders of the Vice-Chancellor". The Executive Council is of the view that, this is gross insubordination. How can he preach to others what he himself does not practice, was the question before each member. The Executive Council resolved that he must be show caused on this matter.

> Since it could not be made out in black & white, as to who was the first one to attack. In light of all allegations and revelations by the committee in the report, the Executive Council unanimously decides to:

> 1. Withdraw all administrative responsibilities from Prof. S.K. Sharma and Dr. Kumar Parag for the next 5 years i.e. 30th April 2030.

> 2. All the members were critical of the incident, the scars of which shall hurt the University for many years to come and censure also be granted as per Vice chancellor versity of Allahabad
