- 2. Bidder is required to submit along with Technical bid details of buses intended to be supplied, showing all dimensions such as wheelbase, overall length, drawings of bus body seating arrangement, necessary certifications etc.
- 3. All dimensions should conform to AIS-052 (upto latest amendment) Bus body design and approval code and other relevant rules.
- 4. The bus shall be designed and manufactured with all applicable fire safety regulations related to CNG buses under CMVR including piping location and layout, location of rubber hose, location of exhaust, sealing from CNG gas entering passenger compartment in case of leakage, catalytic converter location, prescribed upholstery material, fire retardant cable, connectors etc. These provisions shall also include the use of fire retardant material , fire detection, escape of gases in case of any leakage, fire walls and facility for passenger evacuation (doors, windows and escape latches) as per statutory requirements besides bus code.
- 5. The CNG cylinders shall conform to Bureau of Indian Standards and shall be duly approved by Department of Explosive and fulfill all other statutory requirements.
