**University of Allahabad** is Established on 23rd September 1887, it is the fourth oldest University of India. It is renowned for high quality research in multi disciplinary research and other academic activities.

In the pursuit of excellence in research, scholarship and dissemination of knowledge enhancement that will serve both the partners- University of Allahabad and IIPA respectively sign a Memorandum of Understanding (MoU) for Academic and Research Collaboration.

Indian Institute of Public Administration, a Society registered under the Societies Registration Act, 1860, having its registered office 5B, Indraprastha Estate, Ring Road, New Delhi which expression unless repugnant to the context shall include its legal representatives of the one part

### **About IIPA**

Indian Institute of Public Administration (IIPA) is an autonomous academic institution of national eminence under Department of Personnel & Training (DoPT), Government of India for training, research and information dissemination in streams related to the ethos

of Public Administration. Centrally located at Indraprastha Estate – one of the most well connected areas of the city-its campus spreads over seven acres, which houses main-office building, hostel, staff quarters and auditorium. Besides conducting Training, Research, Consultancy, Seminars and Workshops, it disseminates knowledge and information on Public Administration and Management by publishing four periodicals, books and by providing library services to its members, monographs.

## **BACKGROUND**

This Document will establish the basic terms to be used in a future agreement between the Parties. The terms contained in this Document are not comprehensive and it is expected that additional terms may be added, and existing terms may be changed or deleted. The basic terms are as follows:

## **GOALS AND OBJECTIVES**

- (a) To strengthen the ties between two academic institutes
- (b) To strengthen the mutual understanding in the area of productive research, training collaboration on sustainable basis.

## **ROLES AND RESPONSIBILITIES**

AU and IIPA have explored and discussed ways to collaborate and have arrived at a broad consensus towards partnering with each other to provide a framework for active cooperation on the research development and academic activities of the two institutions:

- (i) Undertaking collaborative research in the various relevant fields as may be decided by the parties.
- (ii) Conducting conferences workshops, training programs and seminars, in areas of mutual interest.
- (iii) Exchange of relevant information and joint publications
- (iv) Exchange of faculties and students for various projects
- (v) Jointly Organizing awareness programmers for society

The MOU is aimed at facilitating collaboration towards advancement of knowledge on the basis of reciprocity, best effort, mutual benefit, and frequent interactions.

## **DURATION OF THE MOU**

This is a non-binding Memorandum of Understanding (MoU) between University of Allahabad and Indian Institute of Public Administration.



The MoU will apply from \_\_\_\_\_ and will continue to apply until \_\_\_\_\_ certain milestone is achieved/termination by either party on the giving of 1 month's written notice to the other.

### **NON -BINDING**

This document does not create a binding agreement between the Party and will not be enforceable. Only the future agreement, duly executed by the Party, will be enforceable. The terms and conditions of any future agreement will supersede any terms and conditions contained in this Document. The Party are not prevented from entering into negotiations with other third parties with regard to the subject matter of the Document.

### **DISPUTE RESOLUTION**

If a dispute or difference arises between the parties out of or in connection with this MOU, either party may give the other a written notice specifying the dispute or difference.

Within 30 days of the date of the notice, a person holding a position of senior management of each party must meet and undertake negotiations in good faith and on a without prejudice basis with a view to resolving the dispute or difference.

### **VARIATION**

The parties may agree to vary any of the requirements of this MOU. Such agreement must be in writing and signed by both parties.

### **ADVERTISING AND ANNOUNCEMENTS**

Unless required by law, an announcement, circular or other public disclosure including promotional materials such as newsletters, brochures, flyers or annual reports, referring to the contents or subject matter of this MOU, must not be made or permitted by a party without the prior written approval of the other party

### **CONFIDENTIALITY**

The parties acknowledge that information disclosed by one party to the other (the disclosing party) in the course of the subject matter of this MOU may be confidential and unless required by law must not be disclosed to a third party except with the prior written consent of the disclosing party.
