**Engagement/ Empanelment of Contractual/ Term Appointment of Teachers for Dr. Ambedkar Centre of Excellence (DACE)**

The Ministry for Social Justice and Empowerment, Government of India, through the Dr. Ambedkar Foundation (DAF) has established Dr. Ambedkar Centre of Excellence (DACE) in University of Allahabad, Prayagraj to provide free coaching to Scheduled Caste students for Civil Services examinations, conducted by Union Public Service Commission (UPSC). The DACE, UoA will have 100 seats for Scheduled Caste candidates out of which 33% to be given to eligible female candidates of SC category. The funding for this centre will be provided by the Government of India through the Dr. Ambedkar Foundation under the Ministry of Social Justice & Empowerment. The DACE will be equipped with the state-of-the-art facilities like classrooms, library, high speed Wi-Fi connectivity, for smooth teaching & learning.

The applications are invited from the eligible candidates suitable for engagement/ empanelment for limited period in DACE, UoA as contractual/ term appointment teachers. The panel will be valid for one year; however, validity of panel may be extended as per the applicable guidelines/norms, if required.

The term of engagement on contract basis will be (for a minimum period of 1 (One) year extendable for one more year subject to satisfactory performance) as per the applicable guidelines/norms.

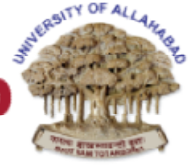

**DUTIES AND RESPONSIBILITIES:**

The selected contractual teachers are required to remain available at least 06 hours daily in the DACE, UoA. The minimum direct teaching-learning process must involve 20 to 25 hours per week. In addition to teaching assignments with course module preparation, the contractual teacher shall perform all such other official duties which are essential for smooth functioning of the Centre. The DACE, UoA will observe 6 days a week and sometimes be open on Sundays/holidays too.

**GENERAL INSTRUCTIONS:**

1. The prescribed essential qualifications are the minimum and the mere possession of the same does not entitle candidates to be called for the interview. Where the number of applications received in response to an advertisement is large and it is not feasible or convenient to interview all the candidates, the University at its discretion, may restrict the number of candidates to a reasonable limit on the basis of qualifications/experience higher than the minimum prescribed for the post. The University, however, prefers candidate possessing higher qualifications and experience.
2. The recruitment shall be made in accordance with the MoU signed between the University of Allahabad and Dr. Ambedkar Foundation (DAF), an autonomous body under the Ministry of Social Justice & Empowerment (MoSJ&E).
3. The process of selection may be by a presentation/interview or a combination thereof.
4. Before applying for a position, applicants are advised to go through the advertisement carefully and satisfy themselves about their eligibility. No enquiry in this regard will be entertained.



5. Reservation for SC, ST OBC, EWS and PwBD shall be applicable as per UGC Guidelines and GOI Rules.
6. Applicants belonging to SC/ST/OBC category should submit proper caste certificate as per the proforma of Govt. of India.
7. Applicants belonging to ESW category should submit proper certificate as per the proforma of Govt. of India.
8. Application received without the requisite documents and after the last date will not be entertained in any case. No queries will be entertained in this respect.
9. Canvassing in any format or bringing of any influence, political or otherwise, will be treated as disqualification on part of the candidate.
10. The selected contract faculty shall provide specialized coaching to the Scheduled Caste Students for the Civil Services examination in his/her subject along with the General Studies and General Knowledge/Civil Services Aptitude Test (CSAT).
11. The services of contract faculty will be terminated without notice if found unsatisfactory. Under any circumstances, candidate cannot claim any right for permanent position.
12. The other relevant 'terms and conditions' are fixed by the University of Allahabad as per the DACE/DAF, The Ministry of Social Justice and Empowerment, GOI.
13. If during the selection process or after selection for Appointment anything irregular or suppression of facts are detected, the application will be rejected and the applicant/candidate will be liable for action as applicable under the provisions of rules and laws in force.
14. Incomplete applications shall be summarily rejected.
15. Candidates must be in sound bodily health. They must, if selected be prepared to undergo such medical examination and satisfy such medical authority as the University may require.
16. The posts are purely contractual in nature and no claim for regularity at any stage will be entertained by the University.
17. Any legal proceedings in respect of any matter of claim or dispute arising out of this advertisement and/or an application in response thereto can be instituted only in Prayagraj and courts/tribunals/forums at Prayagraj.
18. All correspondence from the University including interview letter, if any, shall be sent only at registered email address/registered post only.
