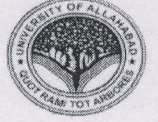

NOTICE

(B.A./B.Sc./B.Com. Part-I Ex-Students only)

In pursuance of Resolution No. 03/49 of the Academic Council in its meeting held on 26.08.2025, and duly approved by the Executive Council in its meeting held on 04.09.2025, it is hereby notified that:

1. The *University of Allahabad Regulations relating to Undergraduate Programmes of Studies for 4-Year Duration and Examinations* [under NEP-2020 Framework], as approved by the Academic Council, shall come into effect from the Academic Year 2025–26 onwards. These Regulations shall also be applicable to **Ex-students of Undergraduate Programmes (B.A./B.Sc./B.Com.)** admitted in previous academic years.
2. To ensure uniform implementation of the NEP-2020 framework, and in view of the fact that no separate annual-based examinations shall be conducted for the first-year Undergraduate Programmes during the Academic Year 2025–26, such ex-students are required to **re-register under the NEP-2020 curriculum** and pursue their studies in the same manner as regular students, with the status of *Ex-Student*.
3. For this purpose, the concerned candidates must submit the prescribed **Re-registration Form/ Ex-Student Form**, duly completed in all respects, on or before **24th October 2025**:

- **Campus students:** at the Student Concerned Counter, FCI Building, University of Allahabad.
- **Constituent college students:** in the Office of the Principal of the respective college.

Note: The subjects earlier chosen shall not be changed.

- In case of **BA/BSc**, out of the three subjects earlier allotted, each student shall have to choose one as a *Minor* subject.
- In case of **BCom**, each student shall have to opt for one *Minor* subject.
- Additionally, all students must register for one **2-credit course per semester** from the AEC/VAC basket, as per the list available on the University website or from the courses offered in the concerned college, following existing rules.

4. Such ex-students shall be required to attend **regular classes, complete Continuous Internal Assessment (CIA), and appear in practical examinations**, as applicable under the NEP-2020 curriculum.

Important Instructions:

- A. This notice is applicable to **B.A./B.Sc./B.Com. Part-I Ex-Students only**.
- B. The related **Re-registration Form (annexed with this Notice)** must be filled in completely and submitted along with the requisite *Ex-Student Fee* as per the existing University rules.
- C. The following **supporting documents (self-attested)** must be enclosed with the form:
- Aadhaar Card of the candidate, ABC ID / APAR No.; Previous year's Marksheet / Admission Card / Fee Receipt
- D. Upon submission of the form, the student will receive a **submission receipt** from the respective counter/college office. With this receipt, the student must approach the concerned **Departments** for registration as an Ex-Student, and also proceed with **AEC/VAC course registration** as per the existing rules of the University.
