The information provided by the applicant in his/her form shall not be changed or altered in any case. **The University shall not be liable for any mistake/error committed by the applicant.**
2. The applicants will have to mention their Social Categories, e.g., UR, SC, ST, OBC and EWS and Sub-Categories, e.g., caste. **The social category mentioned in the application form cannot be changed/modified at any level.**
3. Every applicant must declare in the registration form if he/she has been penalized by a court of law or if any disciplinary/police action is pending against him/her. Failing which the candidature of the applicant shall be cancelled at any point of time by the competent authority of the University of Allahabad.
4. Applicant may apply for multiple subjects as per the eligibility criteria given in the admission brochure. Each subject requires a separate application and payment of the prescribed registration fee.

The University of Allahabad shall invite application for admission to the degree of Doctor of Philosophy (Ph.D.) (here in after referred to as Ph.D. Programme) of the University of Allahabad for the session 2025-26 in the subjects specified in SECTION 2 of this Brochure.

Applicants desirous for admission to the degree of Ph.D. Programme must hold a Master's degree (or a degree recognized by the University as equivalent thereto) in a relevant subject from the University, or any other University or an Institution recognized by UGC, and must fulfil other prescribed conditions of eligibility.

Regular teachers of the University of Allahabad and of any institution / Constituent Colleges maintained by it or admitted to its privileges and International Applicants / Officers of Armed Forces are exempted from NTA test for admission to Ph.D. Programme. All other applicants are required to qualify the JRF/NET/PhD Admission only conducted by NTA for admission to the Ph.D. Programme in the concerned subjects.

All the applicants, **including exempted applicants**, shall register and submit their application form through the ONLINE APPLICATION AND REGISTRATION PROCESS and deposit the required FEE in the prescribed manner at the website <https://aupravesh2025.cbtextam.in/> or Ph.D. Admission-2025 link available on www.allduniv.ac.in.

The details and instructions in respect of Ph.D. Admission-2025, the procedure applicable to the Regular teachers of the University of Allahabad / Constituent Colleges, Officers of Armed Forces candidates and International Applicants exempted from Ph.D. Admission-2025 and relevant information on the Ph.D. Programme are set out in the following sections of this Bulletin.

SECTION 1: INFORMATION- AT A GLANCE

- 1.1. All applicants seeking admission to the Ph.D. Programme of the University of Allahabad for the session 2025-26, in the subjects listed in Section-4, shall have to qualify in the Examination Conducted by National Testing Agency (NTA) for Ph.D./NET/JRF programme.
- 1.2. All applicants shall be required to fulfil the following ELIGIBILITY CRITERIA for applying for admission to the Ph.D. Programme in University of Allahabad.
- 1.3. The minimum score required, as laid down by UGC, at the Post-Graduate Examination is 55% marks (or the equivalent Letter Grade / Grade Point under the seven-point Letter Grade Scale), in the case of UR candidates and 50% marks (or the equivalent Letter Grade/ Grade Point) in the case of EWS/ OBC/ SC/ ST/ PwD candidates. For the said purpose, the percentage of marks obtained by the candidate **shall not** be rounded-off to the next higher integer.
- 1.4. **Except exempted applicants, all the applicants must appear and qualify for award of JRF and appointment as Assistant Professor/ Appointment as Assistant Professor (NET)/Admission to Ph.D. only.**
- 1.5. **Exemptions:** The following categories of candidates shall be exempted from the appearing test conducted by NTA for admission to Ph.D. However, these categories of applicants are required to appear for interview and presentation at the concerned Department/Center/Institute of the University of Allahabad:
 - (i) **Teachers Applicant:** Permanent Teachers of the University of Allahabad or its Constituent Colleges who are seeking admission to the Ph.D. programme are exempted from test conducted by NTA for admission to Ph.D. and be separately assessed at Department/Center/Institute level. They shall be considered SUPERNUMERARY and will not be counted for the overall limit of candidates enrolled under the supervisor. Regularly appointed teachers of the University of Allahabad (including Institutes, Independent Centres and Constituent Colleges of the University of Allahabad) desirous of admission to the Ph.D. Programme in their respective subjects should apply Online for the Ph.D. Programme in the manner specified in the proviso to clause 1(c) of the Ordinance LVI (The Doctor of Philosophy Programme) of the Second and Revised Ordinances of the University of Allahabad.
 - (ii) **This exemption is available only to the regular and permanent teachers of the University of Allahabad and its Constituent Colleges.** The exemption mentioned in Clause-1.5.1 will not be applicable to the ward of any serving or retired, part time/full time Teacher/Employee of the University of Allahabad.
 - (iii) **The term Teacher referred in Clause-1.5.1 means Assistant Professor/Associate Professor/ Professor duly appointed by the competent authority against substantive post in any Department/Centre/Institute in the University of Allahabad and its constituent colleges.**
 - (iv) **Officers of Armed Forces:** Serving Army, Navy and Air Force Officers with not less than 15 years of service and holding the rank of Colonel in the Army, or equivalent rank in the Air Force / Navy, who are applying for Ph.D. in the **Department of Defence and Strategic Studies** are exempted from test conducted by NTA for admission to Ph.D. and be separately assessed at Department/Center/Institute level against a specified number of vacancies.



- (v) **International Candidates:** International Candidates seeking admission to the Ph.D. Programme should contact the International Candidate Advisor of the University, who shall issue appropriate instructions to such Candidates, who fulfil the qualifications for being considered for admission to the Ph.D. Programme. The cases of International Applicants are subject to the provisions of the third proviso to clause 1 (a) (iii) of the Ordinance LVI of the Second and Revised Ordinances of the University of Allahabad. The process and schedule for the admission of International Applicants may be different from that for the candidates qualifying Ph.D. Admission and the Teachers referred to in Clause-1.5.1.
- (vi) **Part-Time Ph.D. Applicant:** The applicant willing to seek admission to the Part-Time Ph.D. Programme and having 05 years of experience in a Government Department/ Public Sector Undertaking/ Research and Development Organisation/Institution/Industry of repute may be admitted to the Ph.D. program on the recommendation of the concerned Doctoral Programme Committee (DPC) with the approval of the Vice Chancellor.
- 1.6. The concerned Doctoral Programme Committee of the Department/Center/Institute of the University of Allahabad shall conduct a Research Aptitude Test (*which shall entail an interview and may include Presentations/Group Discussions/Written or other modes of appraisal*).
- 1.7. **Guidelines for Reservation:** Reservation in Ph.D. Programme shall be implemented, as per MHRD/UGC directions, Government Orders, and guidelines issued from time to time.
- (i) There shall be a reservation of 15% seats for the Scheduled Caste (SC), 7.5% for the Scheduled Tribe (ST), 10% for Economically Weaker Sections (EWS) and 27% for the Other Backward Class Non-Creamy Layer (OBC) Categories. A horizontal reservation of 5% shall be extended, across the reserved and unreserved categories, for the Person with Disability (PwD) candidates shall be considered in accordance with the relevant provisions in this regard.
- (ii) If the seats allocated under the ST category remain unfilled, then the remaining seats under ST category will be allocated to the eligible SC category candidates and vice-versa. But if seat(s) remain vacant in SC/ST, the same will not be transferred to any other category for admission in Ph.D. Programme.
- (iii) Reservation shall be implemented for SC/ST/OBC/EWS/PwD categories, if the calculation of seats for a given category is ≥ 0.5 .
- 1.8. **Person with Disability (Divyang/PwD):**
- (i) As per section 32(1) of the Rights of Persons with Disabilities Act, 2016, all Government institutions of higher education and other higher education institutions receiving aid from the Government shall reserve not less than 5% seats for person with benchmark disabilities. Therefore, 5% of total seats for these courses will be available for person with disability who can pursue these courses without any difficulty.
- (ii) A candidate who has a certified disability of not less than 40% in any limb or in orthopaedic structure which, in the opinion of the Medical Board (constituted by the University of Allahabad), amounts to an overall physical handicap of not more than 70% or is a certified Visually impaired or a Hearing impaired, may be admitted to the concerned course / subject, irrespective of his position in the order of merit of the total aggregate score, on the recommendation of the Medical Board.



- (iii) Seats under this quota shall be filled in order of preference given below. One percent each shall be reserved for person with benchmark disability under clause (a), (b), (c), (d) and (e) namely.
- Blindness and low vision.
 - Deaf and hard of hearing.
 - Locomotor disability including cerebral palsy, leprosy cured, dwarfism, acid attack victims and muscular dystrophy.
 - Autism, intellectual disability, specific learning disability and mental illness.
 - Multiple disabilities amongst person from clauses (a) to (d).
- (iv) The privilege shall not be given except claimed by the candidate at the time of application. At the time of admission, the candidate shall be required to produce a certificate issued by the Chief Medical Officer of the appropriate District or by the Viklang Kendra, Prayagraj, which testifies to his disability and bears an attested photograph indicating their disability clearly.
- (v) Admission under PwD quota for Ph.D. admission will be strictly on the basis of merit list prepared by the Doctoral Programme Committee of the concerned Department.
- (vi) All candidates entitled to be admitted under the above quota to a course shall be adjusted against their respective social category.

Note: For admission under this category, it is mandatory for candidate claiming such quota to appear before the Medical Board duly constituted by the Dean, Students Welfare (DSW).

1.9. A **LIST OF ELIGIBLE CANDIDATES** for the Research Aptitude Test (*which shall entail an interview and may include Presentations/Group Discussions/Written or other modes of appraisal*), shall be announced by the Core Committee for Admission on the basis of the following considerations:

- The total vacancies in any Department/Institute/Centre/College in any session will depend on the number of approved research supervisors of the Subject/College/ Centre concerned. The said vacancies shall be notified in advance at the time of inviting applications for Ph.D. programme for each academic session.
- The applicants shall be classified into the following Three Groups:

For applicants in Group B, the validity of UGC/CSIR NET scores will be valid for one year. Therefore, ***"Candidates who have qualified UGC/CSIR NET in June 2024, December 2024 and June 2025" will be eligible for academic session 2025-26.***

- 1.10. The Core Committee for Admission shall publish the number of vacancies as intimated by the respective Head/Coordinator/Director/Principal of the Department/ Centres/ College in the respective subject.



- 1.11. In accordance with the UGC Regulation 2022 and Ph.D. Ordinance of the University of Allahabad (*vide letter no. 05/R/539/2019 dated 20th June 2019*), **70% of weightage will be given to the examination conducted by NTA and 30% to the Test**, (*which shall entail an interview and may include Presentations/Group Discussions/Written or other modes of appraisal*). The shortlisting criteria for the admission shall be, Marks Obtained by the applicant in the examination conducted by NTA only. When the CSIR/UGC publish normalised score for any subject then for shortlisting of these applicants normalised score obtained by them shall be considered.
- 1.12. The obtained marks/normalised score of the Exam Conducted by NTA shall be converted out of **Seventy** for Table 2.
- 1.13. Interview shall be conducted only of those eligible candidates who have submitted the online application form and shortlisted for interview. The interview will be conducted in the respective Departments of the University of Allahabad.
- 1.14. All the applicants are required to appear before the concerned DPC for Research Aptitude Test (*which shall entail an interview and may include Presentations/Group Discussions/Written or other modes of appraisal*).
- 1.15. The Ph.D. admission will be based on the combined merit of NTA marks, Academic Performance Score and the marks obtained in the Test, (*which shall entail an interview and may include Presentations/Group Discussions/Written or other modes of appraisal*). However, the selection under exempted category as specified in clauses 1.5.1, 1.5.4, 1.5.5 and 1.5.6 shall be on the basis of their performance in interview only.
- 1.16. The final merit shall be prepared on the basis of Table 2.

SECTION 2: REGISTRATION PROCESS

- 2.1. All applicants should apply to the Director, Admission, through the ONLINE APPLICATION AND REGISTRATION PROCESS from the website <https://aupravesh2025.cbtextam.in/> OR Ph.D. Admission-2025 link on www.allduniv.ac.in, in accordance with the instructions set out this brochure.
- 2.2. The rules and procedures for admission/registration and matters applicable to the Ph.D. students shall be governed by the Ordinance LVI (The Doctor of Philosophy Programme) of the Second and Revised Ordinances of the University of Allahabad and other relevant Ordinances, Regulations and rules of the University of Allahabad.
- 2.3. All admissions to the Ph.D. Programme shall initially be on PROVISIONAL basis and the admitted candidates shall be required to attend and attain the minimum requisite standards and shall be required to complete the Pre-Doctoral Programme offered by the respective Department/Unit/Centre.
- 2.4. The candidate shall be allowed to continue with the Ph.D. Programme/submission only upon the successful completion of the Pre-Doctoral Programme of at least one Semester (six months) duration.
- 2.5. Under the provisions of clause 1(c) of the Ordinance LVI of the Second and Revised Ordinances of the University of Allahabad, an employed candidate (other than a teacher referred to in Clause-1.5.1) shall not be considered for admission to the Ph.D. Programme except upon submitting a 'No Objection Certificate' from his/her employer to the effect that the candidate, If posted within the territorial area of the University, shall be permitted to report for research work to the Department/Institute/Centre concerned and to attend course-work and other academic activities there or at other location or if posted outside or transferred from, the said area, shall be granted leave of absence for the requisite period to fulfil the requirement of residence within the area.
- 2.6. A candidate who takes up employment after joining the Ph.D. Programme shall be required to immediately give information in writing to the effect to the Head/Director/Coordinator of the Department/Institute/Centre where he/she is enrolled, and his/her admission shall be subject to the provisions of clause 1(c) referred to in Clause-2.5. In case the candidate conceals such information or fails to present the prescribed 'No Objection' Certificate of the employer for continuing in research, or defaults on any other applicable condition in this regard, he/she shall not be entitled to continue in the Ph.D. Programme and his/her admission to the Ph.D. Programme shall stand terminated.
- 2.7. No candidate (except part-time candidates) admitted to and enrolled in the Ph.D. Programme shall be entitled to continue in, or accept, any remunerative assignment during the period of enrolment in the Programme, other than a Fellowship/Scholarship/other stipend awarded for pursuing the Programme.
- 2.8. **The University shall not provide any Scholarship or Financial benefit to the Research Scholar admitted in the Constituent Colleges of the University of Allahabad.** However, the concerned college or any financial agency may provide scholarship or financial benefit to them.



- 2.9. No candidate admitted to and enrolled in the Ph.D. Programme shall be entitled to continue in or join any other Degree course or any full-time Diploma/Certificate course of the University of Allahabad or of any other University/ Institution. However, he/she may be permitted (or required) to join a part-time or add-on Diploma/ Certificate course, in according with the provisions of Ordinance LVI of the Second and Revised Ordinances of the University of Allahabad and other relevant Ordinances of the University.

2.10. Duration of the Programme

- 2.10.1. Ph.D. Programme shall be for a minimum duration of three (3) years, including course work, and a maximum duration of six (6) years from the date of admission to the Ph.D. programme.
- 2.10.2. A maximum of an additional two (2) years can be given through a process of re-registration as per the Statute/Ordinance of the Higher Educational Institution concerned; provided, however, that the total period for completion of a Ph.D. programme should not exceed eight (8) years from the date of admission in the Ph.D. programme, provided further that, female Ph.D. scholars and Differently Abled (having more than 40% disability) may be allowed an additional relaxation of two (2) years; however, the total period for completion of a Ph.D. programme in such cases should not exceed ten (10) years from the date of admission in the Ph.D. programme.
- 2.10.3. Female Ph.D. Scholars may be provided Maternity Leave/Child Care Leave for up to 240 days in the entire duration of the Ph.D. programme.
- 2.11. An eligible Professor/Associate Professor/Assistant Professor can guide up to eight (8) / six (6) / four (4) Ph.D. scholars, respectively, at any given time.
- 2.12. Faculty members with less than three years of service before superannuation shall not be allowed to take new research scholars under their supervision. However, such faculty members can continue to supervise Ph.D. Scholars who are already registered until Superannuation and as a co-supervisor after superannuation.
- 2.13. A Co-Supervisor from allied Subject/Department/Center/Institution/College of the University may be permitted. The allotment of supervisor and co-supervisor shall be as per UGC Regulation, 2022; Ph.D. Ordinance, 2019 and decision of the Academic Council in its meeting held on 22/07/2025 *vide resolution number 9/48*.
- 2.14. Each Supervisor can guide Teacher Applicant(s) and up to one International Research Scholars on a Supernumerary basis over and above the permitted number of Ph.D. Scholars as mentioned in the UGC Regulations, 2022. However, Regular and Part-Time Ph.D. scholars shall be counted in the total permitted seats prescribed in the UGC Regulations, 2022.
- 2.15. No faculty member shall act as co-supervisor of more than One Student at any given point of time.
- 2.16. If the NTA (UGC/CSIR NET) shall not conduct examination for any subject or NO Applicant with qualified NTA Exam is available for any subject(s), the University may consider to conduct an Examination for such **Specific Subject(s)**.



SECTION 3: PART-TIME PH.D. PROGRAMME

- 3.1. **Procedure for Admission to Ph.D. through Part-time Mode-** Ph.D. programmes through part-time mode will be permitted, provided all the conditions stipulated in UGC Regulations 2022 are fulfilled. The applicant desirous for admission to a part-time Ph.D. programme shall submit a “*No Objection Certificate*” from the appropriate authority in the organization where the candidate is employed, clearly stating that:
- The candidate is permitted to pursue studies on a part-time basis.
 - His/her official duties permit him/her to devote sufficient time for research.
 - If required, he/she will be relieved from the duty to complete the course work.
- 3.2. Notwithstanding anything contained in UGC Regulations 2022 or any other law, for the time being in force, the University of Allahabad shall not conduct Ph.D. programmes through distance and/or online mode.
- 3.3. The course work for such candidate may be conducted in online/offline/hybrid mode. Part-time scholars must submit **half-yearly progress reports duly forwarded by the Research Advisory Committee (RAC) to the DPC**. Such scholars shall be exempted from the period of residence.
- 3.4. The maximum permissible seat for part time PhD programme shall be one for each supervisor subject to overall seat prescribed for supervision by Assistant Professor/Associate Professor/Professor as per UGC Regulation 2022.
- 3.5. The following categories of applicants are eligible for consideration in Part-Time Ph.D. programme:
- 3.5.1. Applicants desirous for admission to the degree of Ph.D. Programme must hold a Master's degree (or a degree recognized by the University as equivalent thereto) with 55% for unreserved or 50% for EWS/OBC/SC/ST/PwD in a relevant subject from the University, or any other University or an Institution recognized by UGC, and must fulfil other prescribed conditions of eligibility.
 - 3.5.2. The applicant willing to seek admission to the Part-Time Ph.D. Programme and having 05 years of experience in a Government Department/ Public Sector Undertaking/ Research and Development Organisation/Institution/Industry of repute may be admitted to the Ph.D. program on the recommendation of the concerned DPC and with the approval of the Vice Chancellor.
 - 3.5.3. Part-Time Scholars (Sponsored) For employed persons working in a public/corporate/ private sector/ industry /department, who are sponsored by the employer to pursue Ph.D. and having at least 5 years working experience in relevant public/corporate or private sectors/industry/organization/institutions shall be admitted to the part time Ph.D.
 - 3.5.4. Part-Time Scholars (Non-Sponsored) for employed persons working in a public/corporate/ private sector/ industry /department, who are allowed but not sponsored by the employer to pursue Ph.D. and having at least 5 years working experience in relevant public/corporate or private sectors/industry/organization/institutions shall be admitted to the part time Ph.D.

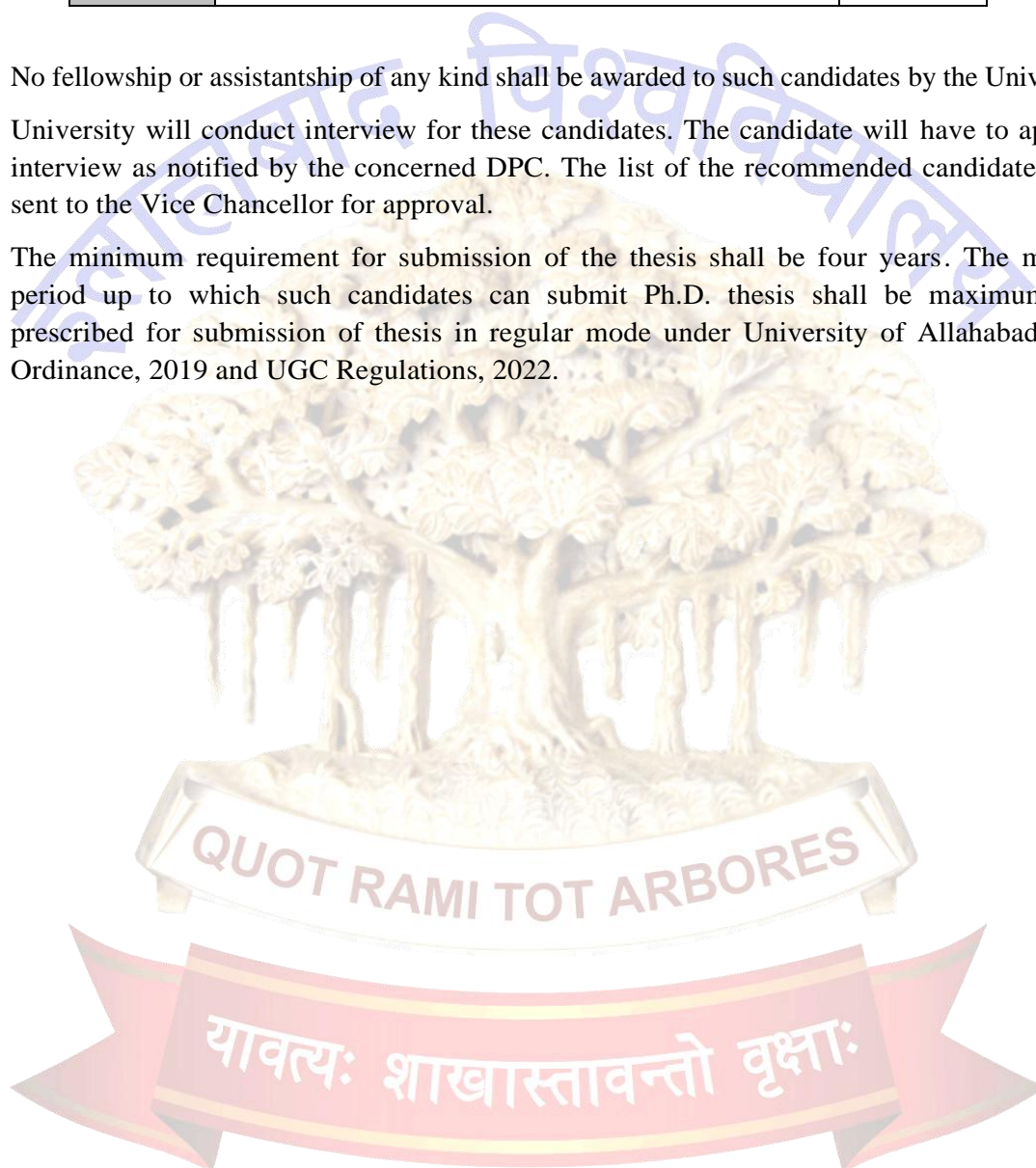
