Information regarding the B.Com. III Viva-voce Examination 2019-20

1. The student has to write on any one of the following topics in the word limit of **600-800 words (maximum eight sheets of A4 size paper)** in his/her own handwriting.
2. List of topics will be uploaded on the **<https://onlineexam.allduniv.ac.in>** and **www.monirba.com**.
3. The students need to download the list of topics from the above site and has to submit the same by **05.10.2020**.
4. The student has to write examination on their own A4 size Answer Sheets. On each sheet the student has to write "**B.Com.-III 2019-20 Viva-voce**", his/her **Roll No.** and **Enrolment No.** on top of each page.
5. Each page of the answer sheet should have page number denoting the order and number of pages. e.g., if the total answer book has 08 sheets, first page should be marked as 1/8, second page should be marked as 2/8 and the last page should be marked as 8/8. Also, total number of written pages must be mentioned on the first page.
6. Once the student has attempted the examination, he/she has to scan all the written pages of Answer Sheets in serial order.
7. The scanned document has to be converted into a pdf file before uploading. The name of the file should be the student's AU_Roll number_viva-voce_eg., if your Roll No. is 111111 and then the file name shall be AU_111111_vivavoce.
8. For uploading the PDF file, the student has to open **the link <https://monirba.com>** **/upload**. On this link, the student has to fill up all the details in submission form therein. Browse and select the PDF file to submitted and click on the upload button.
9. The student may submit the same in hard copy in their respective colleges/units.
10. Those students, who fail to do so, will be provided another chance during second examination.
11. Students must use either Blue or Black Pen only.
